- 1. Blackout dates and issue master can be registered.
- 2. Application details(e.g. status), blackout dates and issue master can be obtained.

- 4. Application details can be obtained only when the application is applied directly on CredNex; when an AP applies on behalf of MM, only the blackout dates and issue master can be obtained.

### **Points to Note**



- The "Administrative Contact" to be registered on the UT-11 should be the contact person(s) for all applications. Please note that for security reasons, applications from persons other than the "Administrative Contact" will not be accepted.
- The e-mail address provided when creating the ID will be used for 2-step verification for login and notifications (C/R application status updates, emergency notifications, function update notifications, etc.), so please be sure to specify an e-mail address with your understanding. In addition, multiple IDs can be obtained with a single e-mail address; basically, an e-mail address is used for the ID, but if multiple IDs are registered with a single e-mail address, the IDs will be numbered and assigned so that they can be distinguished by ID. (Example of ID numbering: (1) ask-crednex@jpx.co.jp, (2) ask-crednex2@jpx.co.jp) If a single email address is registered for multiple IDs within the same organization\*, only single notification email from CredNex will be sent.
  \*The AP prop-desk and agency-desk are treated as separate organizations. Also, the application authority and approval authority IDs for the AP prop-desk are treated as separate organizations. If the same e-mail address is registered for different organizations, multiple notification e-mails with the same content may be sent.
- Sharing the ID is not recommended; if you use one ID to log in from two or more terminals
  at the same time, you may experience unexpected behavior such as being forcibly logged out
  after a certain period of time.
